



Vendor Contract

The 74th Annual Loggerodeo will be held June 27th through July 5th in Sedro-Woolley, Washington. The oldest 4th of July celebration in the state will have events throughout the week. More information is available at our website www.loggerodeo.com.

The goal of the Loggerodeo Committee is to provide our patrons with a fun-filled family experience that will educate, entertain and provide them with memories that will last a lifetime. This means that the quality of our visitors experience is important. We also seek to work with you to provide you with a positive vending experience at Loggerodeo. While we cannot guarantee your success, we do seek to provide an event in which you will want to participate year after year.

The Loggerodeo Committee does not make any specific guarantees as to the number of attendance for this event. There are no refunds, including but not limited to Acts of God.

1. By signing this contract the vendor agrees to pay the specified booth rental fee. All checks will be payable to Loggerodeo.
2. All applications and appropriate fees must be turned in no later June 25, 2008. If you need accommodations after this date please call Jeanne McLennan prior to the deadline at 360-770-8452. All fees will need to be paid prior to event date.
3. Vendor agrees to submit a certification of insurance no later June 25, 2008. Vendors will not be allowed to participate in the event if insurance has not been received by June 30, 2008 and will forfeit all fees paid to that point.
4. Vendor agrees to indemnify and hold harmless: The City of Sedro-Woolley, Skagit County, Loggerodeo and the staffs and boards of these organizations against any claim or action for any cause. Vendor agrees that they will be responsible for their own insurance under this hold harmless clause, which is part of this contract.

5. Vendors must list items they will be selling, distributing, advertising or promoting. Example: sausage, fries, lemonade, novelty items, promotion material, etc. We understand novelty items may be extensive to list so list these items as reasonably as specific as possible. Merchandise, food or other materials being sold, promoted, displayed, given away or marketed shall be conducted within the designated space rented by the vendor.
6. Any materials the Loggerodeo deems obscene, dangerous, unlawful or otherwise inappropriate for a family friendly environment is strictly prohibited from sales, promotion and display or advertised in anyway. No, Alcohol, drugs, or firearms are permitted.
7. The Skagit County Health Department may inspect each vendor site that will be selling food to verify proper certification. The Loggerodeo board will not be responsible for any actions the health department may deem necessary and will not redeem vendor fees if a vendor is not permitted to conduct food sales. Any questions regarding food-handling issues contact the Skagit County Health Department at 360-336-9380.
8. All merchandise belonging to anyone will be the sole responsibility of the owner. The City of Sedro-Woolley, Skagit County, and Loggerodeo will not be responsible for missing or damaged property.
9. Each vendor will be responsible for keeping their area free of trash and debris within and immediately around their individual spaces and when each vendor removes their equipment, merchandise and materials from their space at the conclusion of the event.
10. There is limited availability for electrical outlets, so please specify if you will need one.

Booth fees for this event are as follows:
FOOD Vendors - \$50 per day / \$150 all 3 days
CRAFT vendors - \$30 per day / \$90 all 3 days
